Election Results

The Reconvened Annual Election was held on November 24, 2020 where the reduced guorum requirement of 25.5% of the voting power was reached. Three candidates were running for two open Board seats for the next two years. The results are as follows: Anthony Markus and Yumi Renshus were elected to serve a 2-year term each. In addition, the membership voted in favor of the IRS Revenue Ruling 70-604, which means that any excess of the membership funds, for the current fiscal year as defined in IRS Regulation 1.277-1, shall be applied against the subsequent tax year member assessments. Pool Deck Update

GREAT NEWS! The Board of Directors unanimously voted to keep the Prosa Pool open and heated through January 30, 2021 for the enjoyment of all residents. The Board will revisit the matter again at the end of January. Enjoy! Construction at the Clubhouse Pool continues. The pavers have arrived and installation of new starting block anchors is complete. 2021 Budget

The 2021 Budget reflects an assessment increase to **\$122.00** per month, a \$4.00 per month increase. This increase is necessary to:

- Adequately cover the rising operating utility cost increases for gas, electric and water.
- Cover contract increases for landscaping janitorial, pool and patrol services.
- ✓ Support the State-mandated minimum wage increase.

With this budget, the Board of Directors does not anticipate that any special assessments will be required to replace, repair or restore any major component of the reserve program in 2021. The 2021 budget will be mailed out in November and becomes effective with the January 2021 payment. If you use auto-payment through your bank, update the amount to \$122.00 effective with the January 2021 payment to avoid late fees. If you use auto debit through PCM, the amount will automatically be changed.

Christmas Tree Pickup







Waste Management will collect and recycle Christmas trees for 2 weeks following Christmas on our regular trash collection day. Trees taller than 6' MUST be cut in half and removed from the stand. ALL decorations including lights, ornaments, and tinsel must also be removed. Place the tree next to your trash. Flocked trees will be collected but not recycled.

Please note that Waste Management does not provide large item pick up during this time. All trucks are dedicated to picking up Christmas trees.

Main Facility Deck Update

Finally, after 42 years of service, our aging, main facility decks of the main pool, spa, wader and clubhouse will be repaired and updated. Underlying electrical issues between tennis courts. spa and main electrical vault will be resolved, along with replacement of disintegrating and fracturing concrete. An ADA compliant ramp will be installed for easier access to restrooms, and outdoor showers will be made ADA compliant. Wasteful irrigation and landscape maintenance will be reduced. Barbecues will be better socially spaced and various other electrical, plumbing, drainage and pools equipment will be repaired and updated (eg. new skimmers). Total cost for this project is \$474,000, in reserves, saved over many years, begun by previous Boards, avoiding any special assessments or loans.

Eucalyptus Windrow Tree Project

After much discussion and many fact-finding meetings, the Board has resolved to commence Level 2 and Level 3 assessments of 43 eucalyptus windrow trees in our neighborhood that are adjacent to homes, in order to provide objective criteria on how to best protect life and property.

A Level 2 risk assessment will include: visual inspection of each tree by a certified arborist, a review of known history, an assessment of overall tree health, and a risk evaluation of potential targets should the tree fall (i.e. homes, vehicles, yards). A Level 3 assessment will use sonic tomography to reveal the internal condition of each tree, including the presence of any disease or decay.

Both of these assessments will be conducted by the same vendor that the City of Irvine uses for their "significant tree program". Results will be published in a future HOA newsletter. Depending on the findings, we will comply with all City of Irvine requirements for removal and replacement with a new tree. Replacement trees may not always be planted in the exact same location.

Our Island Jacaranda Trees

The ARC and Board are discussing the island Jacaranda Trees. Over the years they've become more and more of a hazard and in the recent wind storms, many have had branches fall due to their size. We'll keep you posted of any updates.
